THE QUALIFICATIONS OF THE HIGH PRIEST

Hebrews 5:1-10

Introduction: Jesus as the Model for Our Ministry

I. The High Priest Had to be Human

- A. In the OT, the high priest had to be human: “chosen from among men” (v.1)
 - o Why human? Because priests were “appointed to act on behalf of men”
 - o Thus it takes a human to represent a human before God
- B. Christ Meets This Requirement: “in the days of his flesh” (v.7)
 - o The author uses the very particular word (σαρκός) which means “flesh” or physical body; same word as John 1:14: “the word became flesh and dwelt among us”
 - o Thus Jesus didn’t just “seem” to be human, but was really a human like us
 - Refutes ancient heresy of “Docetism” (idea that Jesus only *appeared* to be human)
- C. Ministry Lesson: The Power of Presence
 - o Key point: being physically present helps us relate to those we minister to

II. The High Priest Had to Experience Weakness

- A. In the OT, the high priest had to experience a fallen world “beset with weakness” (v.2)
 - o This allowed the high priest to “deal gently with the ignorant and wayward” (v.2)
 - o Unfortunately, for all high priests this also included their sin: “he is obligated to sacrifice for his own sins just as he does those of his people” (v.3)
- B. Christ meets this requirement: He experienced severe suffering (v.7-9)
 - o “Jesus offered up prayers and supplications, with loud cries and tears” (v.7a)
 - What is this a possible reference to?
 - Do you realize that Jesus suffered *greatly* while on earth?
 - o “Jesus offered up prayers and supplications, with loud cries and tears” (v.7a)



- o "He was heard because of his reverence" (v.7b)
 - "reverence"=posture of trust and submission
 - What would it look like to suffer in a posture of submission to God?
 - o "He learned obedience through what he suffered...being made perfect" (v.8-9)
 - How could Jesus be "made" perfect if he was already perfect as the Son of God?
 - o "[As a result] He became the source of eternal salvation to all who obey him" (v.9)
 - Christ's obedience in the face of suffering made him the ultimate high priest
- C. Ministry Lesson: The School of Suffering
- o Key Question: How Does Suffering Make Us More Effective in Our Ministries?
 - C.S. Lewis: "Pain insists upon being attended to. God whispers to us in our pleasures, speaks in our conscience, but shouts in our pain: it is His megaphone to rouse a deaf world."
 - o Can you think of scriptural examples where suffering was a preparation for ministry?

III. A High Priest Had to Be Called

- A. In the OT, the high priest was not self-appointed
- o "And no one takes this honor for himself, but only when called by God" (v.4)
 - o "Ordination": when someone is officially recognized and set apart as called by God
- B. Jesus meets this requirement
- o "So also Christ did not exalt himself to be made a high priest, but was appointed by him" (v.5)
 - o The author cites Psalm 2:7 and 110:4, classic OT texts about God's appointment of Jesus
- C. Ministry Lesson: Humble Thyself
- o What are signs that our ministry has become about our own glory?
 - o Key phrase: "humble confidence"
